

## **Rooted in Relationships Coaching Implementation Guide—Year 1**

- Coaching dosage for Year 1 is **2.5** hours per month for each provider.
- Coaching agendas should be used for all coaching conversations.
- Provider Collaboration Meetings will need to occur 6-12 times
- Coaches are required to attend Reflective Consultation every month.
- All coaching conversations will need to be entered into the Coach Management System (CMS) following the coaching session.
- Refer to the <u>Rooted in Relationships Evaluation Guidebook</u> for specific evaluation information.

\*Training and Provider Collaboration Meetings do not necessarily have to take place in the months outlined above. Communities need to ensure that Year 1 consists of the RiR Director Training, Module 1A, Module 1B, Module 2A, and Module 2B, and 6-12 Provider Collaboration Meetings. Scheduling can be determined by the community.

\*\*When using TPOT or TPITOS data to guide coaching, it is important to remember not to share actual scores with providers. The debrief form given to them by the observer will have clear strengths and next steps that can be used.

Coaching conversations will also focus around transitioning into Year 2.
